MEMORANDUM OF AGREEMENT FOR THE RELEASE OF GOVERNMENT-OWNED OR DEVELOPED SOFTWARE

- 1. Distribution of Fast line-of-sight imagery for target and exhaust-plume signatures (FLITES) scene generation program is performed by DSIAC on behalf of AFRL/RWTS.
- 2. The Fast Line-of-Sight Imagery for Target and Exhaust Signatures (FLITES) code contains sensitive technologies which must be protected from any disclosure or distribution to foreign interests. Appropriate safeguards must be taken to prevent such disclosure or distribution. Access to the FLITES code and related documentation is limited to those U.S. citizens (no foreign nationals) directly employed by the requesting organization (i.e., no support contractors or subcontractors). Furthermore, access is restricted to persons actually involved in the installation and use of FLITES. Additionally, it has been determined that the FLITES computer software and documentation are subject to Export Control laws under the Arms Control Act (Title 22, U.S.C., Sec. 2571 et seq.) or Executive Order 12470.
 - "WARNING The subject computer software and documentation contain information whose export is restricted by the Arms Control Act (Title 22, U.S.C., Sec. 2571 et seq.) or Executive Order 12470. Violators of these export laws are subject to severe criminal penalties."
- 3. The requestor acknowledges that FLITES is not to be used for any purpose other than the contract or CRADA number specified in the model request.
- 4. The requestor agrees that they will not release, or transfer FLITES to anyone without prior written approval from the DSIAC.
- 5. The requestor agrees to return FLITES to DSIAC upon completion of the work specified in the model request. The requestor may be eligible to retain FLITES if there is additional U.S. Government work, including IRAD, or another U.S. Government contract for which FLITES is required. Contact the DSIAC for additional guidance.
- 6. The requestor agrees that they may only use FLITES within 3 years of a completed, signed, and valid MOA and within an approved contract's period of performance.

- 7. The requestor agrees that FLITES, or any modified version thereof, shall not be published for profit or in any other manner offered for sale to the U.S. Government and shall not be sold or provided to any other activity or firm. If FLITES is modified using U.S. Government funds, the U.S. Government maintains unlimited rights to the modifications, regardless of if FLITES is the basis of, or incidental to, a contract. FLITES, and modified versions thereof, may be used in the performance of a contract with the U.S. Government but no development charges may be assessed as part of its use.
- The requestor acknowledges that the U.S. Government is neither liable nor responsible for maintenance, updates, or correction of any defects in FLITES. Suspected software defects, improvement suggestions, or other change requests should be provided to the DSIAC or recorded directly in the DSIAC Software Change Request (SCR) database for submission to the respective FLITES Model Manager and Configuration Control Board (CCB).
- 9. The requestor acknowledges that the distribution of FLITES may include sensitive technology and information that is classified DISTRIBUTION STATEMENT F. Further dissemination only as directed by (2022 June 02) or higher DoD authority and that any such information released to the requester, in whole or in part, shall be controlled and safeguarded in accordance with the appropriate NISPOM security regulations.
- 10. The requestor acknowledges that the information received is intended for domestic use only. The requested information shall not be used for or made available to foreign governments nor used in any contract with a foreign government without the written approval of the appropriate U.S. Government agencies.
