MEMORANDUM OF AGREEMENT FOR THE RELEASE OF GOVERNMENT-OWNED OR DEVELOPED SOFTWARE

- 1. Distribution of the Next Generation Fire Model (NGFM) is performed by DSIAC on behalf of the 704th Test Group (704 TG/OL-AC), Aerospace Vehicle Survivability Facility (AVSF).
- 2. The requestor acknowledges that NGFM is not to be used for any purpose other than the contract or CRADA number specified in the model request.
- 3. The requestor agrees that they will not release or transfer NGFM to anyone without prior written approval from the DSIAC.
- 4. The requestor agrees to return NGFM to DSIAC upon completion of the work specified in the model request. The requestor may be eligible to retain NGFM if there is additional U.S. Government work, including IRAD, or another U.S. Government contract for which NGFM is required. Contact the DSIAC for additional guidance.
- 5. The requestor agrees that they may only use NGFM within 3 years of a completed, signed, and valid MOA and within an approved contract's period of performance.
- 6. The requestor agrees that NGFM, or any modified version thereof, shall not be published for profit or in any other manner offered for sale to the U.S. Government and shall not be sold or provided to any other activity or firm. If NGFM is modified using U.S. Government funds, the U.S. Government maintains unlimited rights to the modifications, regardless of if NGFM is the basis of, or incidental to, a contract. NGFM, and modified versions thereof, may be used in the performance of a contract with the U.S. Government but no development charges may be assessed as part of its use.
- 7. The requestor acknowledges that the U.S. Government is neither liable nor responsible for maintenance, updates, or correction of any defects in NGFM. Suspected software defects, improvement suggestions, or other change requests should be provided to the DSIAC or recorded directly in the DSIAC Software Change Request (SCR) database for submission to the respective NGFM Model Managers and Configuration Control Board (CCB).
- 8. The requestor acknowledges that receipt of NGFM is only for U.S. Department of Defense organizations and their contractors and is export controlled. NGFM shall not be used for, or made available to, foreign governments nor shall it be used in any contract with a foreign government without the written approval of the appropriate U.S. Government agencies.
