## MEMORANDUM OF AGREEMENT FOR THE RELEASE OF GOVERNMENT-OWNED OR DEVELOPED SOFTWARE

1. Distribution of the Aircraft Flight Dynamics, Flight Path Generator, Maneuver, Mission, and Aero-Performance Evaluation Model (BlueMax7) is performed by DSIAC on behalf of AFLCMC/EZJA.
2. The requestor acknowledges that BlueMax7 is not to be used for any purpose other than as specified in the contract or CRADA number in the model request.
3. The requestor agrees that they will not release or transfer BlueMax7 to anyone without prior written approval from the DSIAC.
4. The requestor agrees to return BlueMax7 to DSIAC upon completion of the work specified in the model request. The requestor may be eligible to retain BlueMax7 if there is additional U.S. Government work, including IRAD, or another U.S. Government contract for which BlueMax7 is required. Contact the DSIAC for additional guidance.
5. The requestor agrees that they may only use BlueMax7 within 3 years of a completed, signed, and valid MOA and within an approved contract's period of performance.
6. The requestor agrees that BlueMax7, or any modified version thereof, shall not be published for profit or in any other manner offered for sale to the U.S. Government and shall not be sold or provided to any other activity or firm. If BlueMax7 is modified using U.S. Government funds, the U.S. Government maintains unlimited rights to the modifications, regardless of if BlueMax7 is the basis of, or incidental to, a contract. BlueMax7, and modified versions thereof, may be used in the performance of a contract with the U.S. Government but no development charges may be assessed as part of its use.
7. The requestor acknowledges that the U.S. Government is neither liable nor responsible for maintenance, updates, or correction of any defects in BlueMax7. Suspected software defects, improvement suggestions, or other change requests should be provided to the DSIAC or recorded directly in the DSIAC Software Change Request (SCR) database for submission to the respective BlueMax7 Model Manager and Configuration Control Board (CCB).
8. The requestor acknowledges that receipt of BlueMax7 is only for U.S. Government Agencies and their contractors and is export controlled. **BlueMax7 shall not be used for, or made available to, foreign governments nor shall it be used in any contract with a foreign government without the written approval of the appropriate U.S. Government agencies.** Contact the DSIAC for additional guidance.
