MEMORANDUM OF AGREEMENT FOR THE RELEASE OF GOVERNMENT-OWNED OR DEVELOPED SOFTWARE

- 1. Distribution of the Advanced Low Altitude Radar Model (ALARM) and the ESAMS, ALARM and RADGUNS Common RF Environment (EARCE) is performed by DSIAC on behalf of AFLCMC/EZJA.
- 2. The requestor acknowledges that ALARM/EARCE is not to be used for any purpose other than the contract or CRADA number specified in the model request.
- 3. The requestor agrees that they will not release or transfer ALARM/EARCE to anyone without prior written approval from the DSIAC.
- 4. The requestor agrees to return ALARM/EARCE to DSIAC upon completion of the work specified in the model request. The requestor may be eligible to retain ALARM/EARCE if there is additional DoD work or another DoD contract for which ALARM/EARCE is required. Contact the DSIAC for additional guidance.
- 5. The requestor agrees that they may only use ALARM/EARCE within 3 years of a completed, signed, and valid MOA and within an approved contract's period of performance.
- 6. The requestor agrees that ALARM/EARCE, or any modified version thereof, shall not be published for profit or in any other manner offered for sale to the DoD and shall not be sold or provided to any other activity or firm. If ALARM/EARCE is modified using DoD funds, the DoD maintains unlimited rights to the modifications, regardless of if ALARM/EARCE is the basis of, or incidental to, a contract. ALARM/EARCE, and modified versions thereof, may be used in the performance of a contract with the DoD but no development charges may be assessed as part of its use.
- 7. The requestor acknowledges that the DoD is neither liable nor responsible for maintenance, updates, or correction of any defects in ALARM/EARCE. Suspected software defects, improvement suggestions, or other change requests should be provided to the DSIAC or recorded directly in the DSIAC Software Change Request (SCR) database for submission to the respective ALARM/EARCE Model Managers and Configuration Control Boards (CCB).
- 8. The requestor acknowledges that receipt of ALARM/EARCE is only for DoD Agencies and their contractors and is export controlled. ALARM/EARCE shall not be used for, or made available to, foreign governments nor shall it be used in any contract with a foreign DoD without the written approval of the appropriate U.S. Government agencies.
